Miscellaneous: This agreement shall become effective on the date signed below and will remain in effect until all responsibilities set out are fulfilled. The parties acknowledge that they will use their best good faith efforts to negotiate and resolve subsequent issues that may arise from this Agreement as a result of unforeseen occurrence and that may alter the condition of the agreement.

Cancellation Policy: This agreement is effective as of the date signed below and shall remain effective until the Event ends on May 7, 2024, or until terminated by either party. All requests for refunds must be in writing, received and confirmed by CIIC 30 days prior to the event. Contracts cancelled up to 30 days of the event will be issued a refund based upon a prorated basis. If sponsoring promotional items, once the contract is signed and the item is in production, there shall be no refunds. CIIC may terminate this agreement at any time by notifying the sponsor in writing or by e-mail. Upon such termination, CIIC shall return to the Sponsor that portion of the Sponsorship fee pro-rated for the time remaining in the contract.
